RUNNINSONOFAGUN dueled four then three wide with SUPER CHOW to his inside, got let out four wide into upper stretch, took sole command with three-sixteenths to go, got collared at the eighth pole, dug in and fought on latched on the aforementioned foe through to the finish while clear for the place honors. TOP GUNNER chased five to six paths off the inside down the backstretch and then four wide through the turn coming under urging at the five-sixteenths, swung six wide into upper stretch and kept on to procure the show honors. SUPER CHOW coaxed from the gate, dueled two to three wide with RUNNINSONOFAGUN to his outside, came under coaxing near the quarter pole, swung three wide into upperstretch, weakened in the final furlong. TWENTY FOUR MAMBA chased along the inside under a ride from the five-sixteenths, cornered just off the inside into upper stretch before taking the inside route straightened away and weakened through to the finish. BABY YODA coaxed from the gate, chased along the inside down the backstretch and then three wide through the turn pushed along from thethree-eighths, angled five to six wide into upper stretch and weakened. DEANDELIVERS coaxed from the start, chased three then two wide under urging from three furlongs out, tipped three to four wide at the top of the stretch, tired. PER RULING.
