BATTLE OF NORMANDY raced just off the leader two wide under a snug hold heading into the first turn, continued to apply pressure to rival through the backstretch, took advantage of the soft pace and let out a notch to race near the lead late on the far turn, hustled along four paths wide into upper stretch, cleared command and kept to task under steady encouragement. RECKONING FORCE settled off the early pace, lacked a clear path leaving the backstretch, edged a bit closer between foes around the far turn, lacked a clear path upper stretch, hustled up between rivals in the final furlong and finished second best. GIGANTE tracked the early pace two wide sitting just off the top flight, hustled along four paths wide in the upper stretch, sustained a steady bid and prevailed for a share. CASH EQUITY (FR) rated off the early pace, picked up the tempo four wide around the far turn, came five paths wide into stretch and had a mild improve. WONDERFUL JUSTICE (GB) set a pressured pace near the inside, got overtaken past upper stretch, ran on then faded late. MASTER OFF FOXHOUNDS was a step awkward at the start, raced off the pace, shifted to the inside near the furlong marker, moved into contention then flattened out. EMMANUEL tugged under a snug hold early, cut the corner entering the stretch, shifted three wide and failed to kick on. PUBLIC SECTOR (GB) stalked the pace, saved ground, tipped two wide and faded in the lane. HADES was a step awkward at the start and failed to move into contention.
