MI HERMANO RAMON traveled two wide between rivals off the pace, brushed with outer rival early on the clubhouse turn, continued in the two path then found the rail on the second bend, tipped out into the stretch, closed in and fought three deep into the final sixteenth, seized command and was able to hold REDISTRICITING (GB) at bay in the closing moments. REDISTRICITING (GB) reserved to the back of the field and moved to the inside, trailed two wide into the far turn, angled four wide around that bend, steered out widest in upper stretch, flew late from outside but ran out of ground. ASTRONOMER raced in range early outside a rival then dropped off the pace, saved ground through the far turn, steered out into the stretch, challenged between rivals with a sixteenth left to run but got outkicked by the top pair. EASTER (FR) tucked inside near the back, steadied behind a trouble rival past the five-sixteenths pole, shifted over to the two path, angled inward in deep stretch and came with a late rally from inside to round out the superfecta. SEAL TEAM (GB) stalked from inside, fell out of range on the backstretch, moved into striking distance again on the far turn, angled three wide into the lane, bid three deep in upper stretch, took over and clear entering the final furlong, challenged by a pair of rivals at the sixteenth pole and yielded late. ZIO JO sat off the pace along the rail, was forced to check by outer rival past the five-sixteenths pole, remained inside and cut the corner into the lane, moved out in deep stretch and improved position. ST ANTHONY traveled in the two path towards the rear, raced outside a rival in the middle stages, chased three deep at the quarter pole, split foes midstretch and also improve position. FAST BUCK fought for the lead inside SUMTER, battled to the top of the stretch, could not kick on with the new leader approaching the eighth pole and weakened in the final furlong. ALMENDARES (GB) reserved in the early going outside a pair of rivals, got brushed early on the clubhouse turn, kept off the inside up the backstretch, moved out and entered the lane in the five path, steered out further in the drive and lacked a rally. CABO SPIRIT vied for the lead three deep then ceded command to inner rivals first time through the stretch, took a stalking position in the two path, drew closer on the far turn and weakened in the drive. SUMTER dueled outside FASTBUCK to the top of the lane, yielded in upper stretch and gave way in the final furlong. MASTEROFFOXHOUNDS hopped slightly at the start, taken to the two path racing in the middle of the pack, rounded the far turn two to three wide and came up empty when called upon.
