WINTERFELL broke outwardly, was taken back after being corrected and settled well off of a hotly contested pace, commenced a run leaving the three eighths, circled six wide with an advance into the stretch, leveled off under left handed asks leaving mid stretch, forged past the embattled leaders inside the sixteenth pole and drew out. CEL TIC CONTENDER bumped with an inner rival at the break, got into a duel to the inside of SPEEDYNESS soon after, carried that head to head scrum past mid stretch, kept on valiantly and got the bob for the place. SPEEDYNESS broke sharply and got locked in a battle two wide and to the outside of CELTIC CONTENDER, held a slim advantage past the furlong grounds, fought on gamely while under strong handling and just missed sec ond. PLAYLIKE A RAVEN settled off the pace, worked between rivals around the turn, dropped inside for the run into the stretch, advanced inside foes leaving mid stretch, ease dout and kepton with good effort to bridge the gap. PETINGAS TWIN rated three wide just off the dueling leaders, was under pressure into the stretch, stayed on with willing pursuit past mid stretch but came up empty in the final yards. CIRCLE P was put a ride off the duel leaving the far turn, circled five wide and to the inside of the winner into the stretch, moved up some near mid stretch then flattened out. LOVE ME TENDER, bumped at the break, raced four wide with pursuit of the leaders, moved up slightly and under a hearty ride nearing mid stretch, failed to kick on near the sixteenth pole and faded LUCKY JEREMY, urged off the pace while saving ground, angled three wide nearing the stretch but failed to respond. HAD TO HAVE HIM was sent up early and prompted inside foes, eased back a bit then chased into the turn, failed to kick on leaving thefar turn and weakened.
