SEE YOU AROUND (IRE) laid in range in the two path, waited along the rail around the far turn, was coaxed while floating out to the four path in upper stretch, and kicked on to draw past an inner foe. IN OUR TIME set the pace in the two path, waited confidently while just off the rail midway around the far turn, drew clear in upper stretch, but was caught by an outer foe late. DE REGRESO stalked in the three path, was cued two wide midway around the far turn, and chased on from the four path down the lane. YATTA settled in midpack along the inside, floated out to the five path in upper stretch, and finished evenly. BELLE OF RIGHTS bumped with an outer foe at the start, tracked in the two path, was ridden in the three path around the far turn, but was one paced in the six path down the lane. GILDED EDGE raced off the pace in the three path, was driven along the rail around the far turn, but made no impact. PEN DULUM bumped with an inner foe at the start, laid in the back of the pack in the four path, waited in the two path around the far turn before angling out passing the quarter, but did not factor. VICT ORIA'S DANCER rated inside but made no closing bid. LIFE'S ANAUDIBLE chased in the three path but faded in the stretch. KALIS PERA (IRE) trailed in the four path and never threatened. VIVE VEUVE raced well back in the three path and never menaced.
