5 FURLONGS. (Turf) (.53) JANUS S. Purse \$140,000 (includes \$15,000 FTBOA - FL TB Owner Brdr Assoc Fund) THREE YEAR OLDS AND UPWARD. Free nomination by Sunday, December 8. \$1,250 to enter. A supplemental nomination fee of \$100 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. *(FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: Three Year Olds: 123 lbs. Older: 125 lbs. Non-winners of a non-restricted stake in 2024 allowed 3 lbs.; Graded stakes placed in 2024 or non-winners of three races other than maiden, claiming, starter or State-Bred allowance, 5 lbs. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners in 2024, non-restricted stakes placed in 2023-24, then by highest earnings in 2024. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at Five Furlongs) (Rail at 66 feet).

COPPOLA broke sharply, set a clear pace along the rail, widened in upper stretch and held safe under a steady drive. ARZAK raced in range three wide, rallied through the lane and narrowed much of the gap. REEF RUNNER slammed into the starting gate, trailed in the three path, swung widest in upper stretch, continued on the left lead and rallied to gain the show in the final strides. THAT'S RIGHT chased the winner two wide, could not gain in the lane and lost the show late. MASSETO (GB) raced off the pace two wide, angled five wide in upper stretch and had a mild rally. OKIRO raced off the pace three wide, was bumped in midstretch and never threatened. AXTHELM failed to menace while racing four wide. SMITHWICK'S SPICE prompted the pace three wide and weakened in the lane. WHENIGETTOHEAVEN chased the pace inside, angled out in the stretch, bumped near the eighth pole and faded. YES I AM FREE had his head turned at the start, raced off the pace two wide, was bumped between foes in midstretch and had no further bids. XY SPEED was outrun inside.
