1/8 MILES. (Turf) (1.442) FT. LAUDERDALE S. Grade II. Purse \$215,000 (includes \$15,000 FTBOA – FL TB Owner Brdr Assoc Fund) THREE YEAR OLDS AND UPWARD. Free nomination by Sunday, December 8. \$2,000 to enter. A supplemental nomination fee of \$200 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. *(FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: Three Year Olds: 123 lbs. Older: 126 lbs. Non-winners of a graded stakes at a mile or over on turf since May 1 allowed 3 lbs.; a graded stakes at a mile or over in 2024 or a non-restricted stakes race at a mile or over on turf since June 1, 5 lbs. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners in 2023–24, graded stakes placed in 2023–24, non-restricted stakes winners in 2024 then by highest earnings in 2024. In the event this race is taken off turf, it may be subject to downgrading upon review of the Graded Stakes Committee. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at One Mile and One Eighth) (Rail at 66 feet)

MAJOR DUDE was fractious in the gate, settled in range two wide between foes, waited for room in upper stretch, got a clear path leaving the eighth pole, kicked in and was up in deep stretch. FORT WASHINGTON raced off the pace three wide around both turns, swung six wide in upper stretch, closed outside and just missed. WIN FOR THE MONEY prompted the pace two wide, took the lead near the quarter pole and led until the final strides. GRAND SONATA saved ground in range, bid inside of foes nearing the eighth pole but was outkicked through the final furlong. SIEGE OF BOSTON saved ground off the pace, tipped out nearing the eighth pole and rallied while lacking a clear path late. CASH EQUITY (FR) saved ground off the pace, swung five wide in upper stretch and was forced to check near the eighth pole. EMMANUEL chased the pace three wide and faded in the lane. LORENZ (BRZ) failed to menace while racing two wide. SARATOGA FLASH set the pace along the rail, drifted out turning for home and tired.
