FORT WASHINGTON raced off the pace three wide around both turns, sw ung six wide in upper stretch, closed outside and just missed. WIN FOR THE MONEY prompted the pace two wide, took the lead near the quarter pole and led until the final strides. GRAND SONATA saved ground in range, bid inside of foes nearing the eighth pole but was outkicked through the final furlong. SIEGE OF BOSTON saved ground off the pace, tipped out nearing the eighth pole and rallied while lacking a clear path late. CASH EQUITY (FR) saved ground off the pace, sw ung five wide in upper stretch and was forced to check near the eighth pole. EMMANUEL chased the pace three wide and faded in the lane.LORENZ (BRZ) failed to menace while racing two wide. SARATOGA FLASH set the pacealong the rail, drifted out turning for home and tired.
