KALE'S ANGEL away in good order, allowed the early speed to go while outsidethat one, continued to stalk into the turn, engaged that same rival in the three path by midway on the bend, put a head in front soon after, shook clear under a firm hand ride nearing the furlong marker and continued to steadily increase that advantage under right handed pressure. INNOVATOR broke alertly inside the winner, set the pace in the two path, offered some resistance to the winner when challenged in the turn then could not keep up through the stretch, comfortably maintained the place. PERFECT MAGIC lost footing at the start, recovered to settle behind the top two in the three path and in hand, could do little with that pair when asked through the lane, not threatened by the others. THREE ECHOES in the second flight early while between horses, continued in even fashion into and through the stretch, lacked closing bid. MY WIFE IS RIGHT broke out a bit and steadied to be last away, moved out three wide through the turn, also found lacking in the drive. TEXAS CREED behind the pace inside, had little for the drive to trail home.
