CASALU tracked four then three deep around the clubhouse turn, drew closer outside rivals leaving the backstretch, bid outside RESOLVE midway around the bend, seized control in upper stretch, put away inner rival with a fur long remaining and stayed clear under right handed urging and strong handling. SCHIL FLIED brushed leaving the gate, settled inside, tipped two wide on the far turn but got boxed in at the five-sixteenths pole, cut back to the inside at the quarter pole, tipped off the fence in upper stretch, finished willingly and edged SUPA SPEED for second. SUPA SPEED rated three deep then moved into the two path around the first turn, drew closer two then three wide on the far turn, moved out in the lane and got outkicked for the place honors. TIGERISH broke in and bumped, pulled between rivals approaching the clubhouse turn, checked off heels early on the bend, traveled along the inside at the back, shifted two wide at the five-sixteenths pole, moved out under left handed urging in the lane and produced a mild rally to round out the superfecta. RESOLVE sped clear and angled in on the first turn, controlled the pace up the backstretch, urged along when taking pressure at the five-sixteenths pole, relinquished the lead in upper stretch and weakened in the late stages. SEA RUNNER stalked in the two path, tugged keenly early on the backstretch, drew closer past the half-mile pole, chased between rivals then a bit off the rail into the lane, moved out in the drive and weakened. CE LA VI CHARLI broke a step slow, became rank racing outside a pair of rivals early, trailed outside a rival on the backstretch, rounded the far turn two then three wide and failed to make an impact. DON'T TELL TAMMO stalked from inside, crept closer past the halfway mark, dropped back along the fence on the far turn and tired.
