1/8 MILES. (1.47) LADIES S. Purse \$150,000 FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD. Lasix not allowed within 48 hours of post time pursuant to HISA Rule 4212. By subscription of \$150 each which should accompany the nominations; \$750 to pass the entry box and an additional \$750 to start. For horses not originally nominated, a supplemental nomination payment of \$750 in addition to the entry and starting fees can be made at any time prior to the closing of entries. The purse to be divided 55% to the owner of the winner, 20% to second, 12% to third, 6% to fourth, 4% to fifth and 3% divided equally amongst the remaining finishers. Weight 124 lbs. Non-winners of Graded sweepstake in 2024-25 allowed 2 lbs.; of a sweepstake other than State-bred since May 1, 2024 allowed 4 lbs.; of two races other than maiden, claiming, starter or State-bred allowance in 2024-25 allowed 6 lbs. A trophy will be presented to the winning owner. Closed Saturday, December 28, 2024 with 15 Nominations.

TIZZY IN THE SKY switched from the rail to the two path early on the first turn, prompted the pace on the outside, took the lead in the three path midway through the far turn, shook clear outside the quarter-pole, responded well under a right-handed crop in upper stretch, remained under the crop until inside the furlong marker then was placed under a solid hand-ride to the finish while much the best. JULIA SHINING was taken in hand early on the first turn, raced in the three path on that bend, settled on the outside, was urged along late on the backstretch, chased in the three path on the far turn, was put to the crop inside the three-eighths pole then driven into the stretch in the four path, pursued the winner in the drive and earned the place. COMPARATIVE dropped from the two path to the rail early on the first turn, was well rated while settling the pace, came under urging near the seven-sixteenths pole, lost the advantage to the winner midway through the far turn, dropped back coming to the quarter-pole, chased while keeping on some in the drive and lacked the needed kick. EVIDENCIAS (BRZ) was last away then dropped back under urging, saved ground on the first turn, moved closer entering the backstretch then was rated off the pace, raced inside while asked on the far turn and lacked the needed kick.
