CLASSY JUDY G leaned out at the start, set the pace along the inside, drove clear in upper stretch, drifted about in the final sixteenth but held sway safely. MANAMA GOLD stalked along the inside, was held up while looming a danger from the pocket around the turn, chased while tipping out to the three to four path in upper stretch, ran on to reach place at the sixteenth pole and narrowed the drifting leader's margin late. FREEBURN pressed outside of the eventual winner, but failed to keep pace with that one while hanging on her left lead in upper stretch, changed leads at the furlong grounds, but continued to give way yet lasted for show. SIX STRING broke a step slow, pursued from midpack along the inside, then from the two to three path turning for home before shifting to the five path into the lane, and ran on one paced to miss reaching show. ROYAL O'HAIGAIN brushed with an inner foe at the start, pursued from the three to four path and made little impact. HOPEITSMYLUCKYDAY was brushed and put in tight quarters between rivals at the start, trailed in the two path then moved up along the inside. LUYV was forced to brush an outer rival at the start, tracked from the four path, but drifted out to the seven path entering the lane and weakened.
