1 MILE. (1.33) FASIG-TIPTON CASH RUN S. Purse \$165,000 (includes \$15,000 FTBOA - FL TB Owner Brdr Assoc Fund) FILLIES, THREE YEARS OLD. Free nomination by Friday, December 20. \$1,500 to enter. A supplemental nomination fee of \$150 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. *(FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: 123 lbs. Non-winners of a Graded stakes race allowed 3 lbs.; Graded stakes placed or non-winners of a race other than maiden, claiming, starter or state-bred allowance, 5 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners, stakes placed, then by highest career earnings. Trophy to the winning owner.

FIVE G vied for the lead in the three path, took command from the two path after the half, was cued passing the quarter, and kicked away down the stretch under a drive. PARADISE CITY bumped with an inner foe at the start, chased in the four path and kept on to get up for place. UNCHAINED ELAINE bumped between foes at the start, rated in the three path, moved up along the rail and was roused midway around the turn, tipped out to the three path at the top of the lane, but flattened. YELLOW bumped with an outer foe at the start, tracked in the four path but faded. FALLON trailed in the two path and was no factor. SWEET NOTE stalked in the five path but weakened. ANDREA led in the four path early but gave away in the three path around the turn.
