NITROGEN settled off the pace while racing two wide, waited for room late on the far turn and in upper stretch, found a seam five wide nearing the eighth pole, kicked in and was up late. LOVE CERVERE had early speed inside, checked while appearing to try to get out entering the first turn, dropped back to midpack, saved ground around the far turn, got through inside of foes nearing the eighth pole, briefly led in deep stretch and was game for the place. CIVETTA stalked the pace inside, angled three wide in upper stretch, took the lead near the sixteenth pole but was narrowly outfinished on both sides. WINNING STREEP trailed in the three path, advanced four wide around the far turn and rallied belatedly. CORRETO dueled inside to midstretch and weakened. FIXIN TO BEE saved ground well back, swung nine wide in upper stretch and improved position. DISCOSTAR failed to menace while racing two wide and swing eight wide in upper stretch. FORWARD DEPLOYED dueled two wide and tired in the drive. GOOD LONG CRY stalked the pace three wide and faded in the stretch. SPECIAL AVIATOR played no factor while racing three wide.
