After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. \*(FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: 123 lbs. Non-winners of a graded stakes at nine furlongs or over on turf since July 1 allowed 3 lbs.; Graded stakes placed since then or non-winners of an open stakes race at nine furlongs or over on turf in 2024–25, 5 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners in 2023–205, graded stakes placed in 2023–2025, then by highest career earnings. In the event this race is taken off turfit may be subject to downgrading upon review of the Graded Stakes Committee. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at One Mile and One Half Miles).

FOREVER AFTER ALL saved ground well off the pace, edged closer two wide between foes around the far turn, swung eight wide in upper stretch, surged outside and was up on the wire. CHOP CHOP tracked the pace two wide around the first two turns, bid three deep rounding the far turn, seized command in upper stretch, drew clear in midstretch and led until the final stride. LA MEHANA (FR) saved ground off the pace, angled four wide in upper stretch, rallied between foes and just missed. WHATLOVELOOKSLIKE stalked the pace inside, bid at the rail in the stretch but was narrowly outkicked. QUEEN REGENT (GB) raced off the pace two wide, angled four wide turning for home, made progress in upper stretch and flattened out late. BEAUTIFUL LOVE (IRE) raced off the pace three and four wide, angled further out in upper stretch, had aim nearing the eighth pole but evened out in the final furlong. BALLADO'S BEACH (ARG) bumped at the start, raced two and three wide and never threatened. LADY FIREFOOT bumped start, saved ground well back, swung widest in upper stretch and was no threat. AVENUE NIEL (IRE) played no factor while racing three wide. MARKSMAN QUEEN (GB) prompted the pace two wide, took the lead near the three-eighths pole, led to upper stretch and weakened. SHILOH'S MISTRESS set the pace along the rail and retreated through the stretch. YATTA chased the pace four and five wide, faltered around the far turn and was eased in the stretch.
