**1 MILE. ( 1.33 ) FRED W. HOOPER S. PRESENTED BY KETELONE VODKA Grade III Purse \$165,000 ( includes \$15,000 FTBOA – FL TB Owner Brdr Assoc Fund ) FOUR YEAR OLDS AND UPWARD. Free nomination by Sunday, January 12. \$1,500 to enter. A supplemental nomination fee of \$150 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. \*(FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: 124 lbs. Non-winners of a graded stakes since July 1 allowed 2 lbs.; a graded stakes race in 2024, 4 lbs.; Graded stakes placed in 2024-25 or non-winners of three races other than maiden, claiming, starter or state-bred allowance race, 6 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners in 2023-25, graded stakes placed in 2023-2025, then by highest earnings in 2024-25. Trophy to the winning owner.**

LITTLE VIC set the pace in the two path, opened up under rousing while just off the rail approaching the quarter, and continued to inch away down the stretch. IMPLEMENTATION raced off the pace inside, moved up under a drive nearing the quarter, tipped out to the three path turning into the stretch, and chased home the winning pacesetter. TUMBARUMBA prompted the pace in the five path, was driven in the four path around the turn, but was one paced down the lane. ROCKET CAN raced in range in the three path, was driven around the turn, got stymied passing the quarter, angled out to the five path at the top of the stretch, but flattened. INSTANT COFFEE bumped with an outer foe and stumbled at the start, was well back in the three path, swung out to the eight path under a ride turning into the lane, but made no impact. UPSTANDING bumped with an inner foe at the start, stalked in the six path, was driven in the five path around the turn, but weakened. CAPE TRAFALGAR raced up close in the four path, was cued in the two path midway around the turn, but retreated. BOURBON RESOLVE trailed in the five path early and never threatened. NORTHERN FLAME rated in the five path but never menaced.
