SHISO SPICY broke sharp, relinquished the advantage off the rail, took over from that foe late in the turn, shook off another forward rival into the lane, well clear late, could not contain the winner. CHATTER forwardly placed while threewide, moved with the runner up on the faltering leader late in the turn, could do no more with that one in the drive nor contain the winner, well clear of the others. FLASH MASTER off a step slow, lacked speed, three wide out of the turn, displayed some mild interest to improve position, no real threat. HELEN'S REVENGE broke back, lacked speed, passed some faltering foes while also not making a serious impact. PIGGY TALES UP raced in mid pack toward the inside, had little left for the stretch run. BATTLESHIPPER remained back in failing to menace in the three path. LADY CRUSH swerved into the gap at the start, was straightened to rush up the inside to take command, showed the way into the turn through a rapid opening quarter and stopped before a half. CLAPPIN GTREES settled off the early pace outside, four to five wide out of the turn, backed up through the lane.
