By Subscription of \$250 by Saturday, February 1. \$1250 to enter; \$1250 additional to start. Supplemental nominations of \$5,000 will be accepted at time of entry which shall include all fees. \$250,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to finishers sixth through ninth. Weight: 124 lbs. Non-winners of a Graded sweepstakes at a mile or over since November 15, 2024, allowed 2 lbs. Non-winners of a sweepstakes at a mile or over since August 15, 2024, allowed 4 lbs. Non-winners of \$55,000 at a mile or over since then allowed 6 lbs. Starters to be named through the entry box by the usual time of closing. The Mineshaft Stakes Presented by Relyne GI by Hagyard will be limited to fourteen (14) starters. Preference will be given in the following manner: graded or group winners in order (I, II, III), then highest lifetime earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee or the supplementary nomination fee if applicable. A trophy will be presented to the winning owner. Nominations Closed - Saturday, February 1, 2025 with 16 nominations.

HALL OF FAME stalked along the inside, then from the two path around the far turn, shifted out to the four to five path to take aim outside of the leading pair entering upper stretch, ranged up to bid outside of a leading KOMOREBINO OMOIDO (JPN) at the sixteenth pole, brushed with that drifting rival shortly after, leaned inwardly and brushed his counterpart while sparring in the closing stages and narrowly prevailed. KOMOREBINO OMOIDE (JPN) pressed the leader from the three path, vied turning for home, led in upper stretch, shifted out while meeting HALL OF FAME's challenge entering the final sixteenth, brushed with that one before being pushed and floated inwardly while dueling nearing the wire and missed. MAYCOCKS BAY set the pace along the inside, vied with an outer presser passing the three furlong pole, got headed by that one in upper stretch and safely managed show. BATTEN DOWN tracked in the four path, pursued within striking range around the far turn, but yielded entering the lane, then kept on in the final furlong to secure fourth. HEROIC MOVE pursued from midpack along the inside, chased turning for home, bid for fourth in upper stretch but was turned away. TUSCAN SKY trailed in the four path, then in the five to six path around the far turn and improved position late. CATCHING FREEDOM raced off of the pace two wide while between horses and made little impact. WARRIOR JOHNNY broke a step slow, raced off of the pace shifting three wide around the first turn, chased in the four to five path around the far turn and faded. THE RIDER OF KOMOREBINO OMOIDE (JPN) CLAIMED FOUL AGAINST HALL OF FAME ALLEGING INTERFERENCE IN DEEP STRETCH. BUT THE OBJECTION WAS DISALLOWED BY THE STEWARDS.
