1¹/₁₆ MILES. (Turf) (1.38) SWEETEST CHANT S. Purse \$165,000 (includes \$15,000 FTBOA – FL TB Owner Brdr Assoc Fund) FILLIES, THREE YEARS OLD. Free nomination by Sunday, January 19. \$1,500 to enter. A supplemental nomination fee of \$150 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. *(FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: 124 lbs. Non-winners of a graded stakes race at one mile or over on the turf allowed 2 lbs.; graded stakes placed or non-winners of a stakes race at a mile or over, 4 lbs. stakes placed or a race other than maiden, claiming, starter or state bred allowance, 6 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners, stakes placed then by highest career earnings. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at One Mile and One Sixteenth) (Rail at 17 feet).

VIXEN laid up close in the three path, bid in the two path entering the far turn, took command midway around the far turn, was cued passing the quarter, and drew clear in the three path down the lane. RAMSEY POND bumped with an outer foe at the start, stalked in the three path, was roused between foes early around the far turn, tipped out to the four path turning into the stretch, and kept on. CORRETO tracked in the two path, was cued between foes passing the quarter, but finished evenly down the lane. FIXIN TO BEE rated in the four path, was coaxed midway around the far turn, swung from the five path into the stretch, but made no impact. LA GIOCONDA bumped with an inner foe at the start, set the pace inside, lost the lead early around the far turn, and gave way. SAIL THESEVEN SEAS had a hesitant start, trailed in the three path, sustained an injury midway around the far turn, immediately pulled up, and was euthanized.
