ECLATANT got bumped by an outer foe at the start, chased in the five path, tipped into the three path and was driven along around the turn, floated out to the six path to take aim at the top of the stretch, continued to close in while staying on her left lead, and drew past inner foes around the final sixteenth. STUNNER stalked in the four path, was coaxed from the three path passing the three-eighths pole, bid passing the guarter, stayed on to inch to the lead passing the eighth pole, but was caught around the sixteenth by an outer foe. THE QUEENS M G tracked in the five path, was cued in the four path midway around the turn, bid in the five path at the turning into the lane, and kept on. UNCHAINED ELAINE got bumped by an outer foe leaving the chute, laid in range along the inside, but got stymied passing the quarter, was roused from the two path at the top of the stretch, but was one paced. FRIDA prompted the pace in the three path but gradually faded. ROJO RITA broke in and bumped an inner foe, then ducked in at the gap leaving the chute bumping and impeding an inner pair, rushed up to set the pace in the two path, was cued from the rail midway around the turn, but gaveway in the final furlong. MY DENYSSE bumped with an inner foe at the start, trailed in the six path and did not factor from the eight path down the lane. COSTA AMALFITANA had to steady early, was wellback in the three path and did not threaten. JUSTINQUESO raced off the pace in the two path, got stymied in the three path midway around the turn, floated out to the seven path turning into the stretch, but weakened. VOLATILED hopped and bumped with an inner foe at the start, raced towards the back of the pack in the six path and never menaced. BEYOND BELIEF bumped with an outer foe at the start, then got bumped and had to check hard leaving the chute, raced in midpack in the three path but retreated. AFTER A STEWARDS INQUIRY ROJO RITA WAS DISQUALIFIED AND PLACED LAST FOR DUCKING IN LEAVING THE CHUTE AND INTERFERING WITH MULTIPLE INNERFOES.
