DISCO BALL forwardly placed while racing three wide, roused turning for home, proved no match for the top pair down the stretch, fully extended to presever the show. CHIRIN GO lacked speed, steered toward the inside turn, lacked a response in the drive. OSBOURNE off a step slow, moved closer into the turn, rode the rail through the bend, came up empty for the stretch run. GOLD LUCK fell back to trail soon after the start and was never a factor.
