SCIPIO allowed to settle at the back then moved closer stalking two wide into the turn, got boxed in past the quarter pole, angled out into the clear entering the stretch, struck the front inside the eighth pole and drove clear in deep stretch. GAME WARRIOR stalked from inside, crossed a bit awkwardly onto the dirt but did not lose momentum, altered out from behind a wall of rivals in upper stretch and finished well to edge FREEDOM'S NOT FREE for the place honors. FREEDOM'S NOT FREE attended the pace four deep, lost contact with the top pairfor a bit before reengaging late on the bend, took over crossing the surfaces, relinquished the lead past the eighth pole and got edged for second on the line. FOMO JOE vied three deep early, chased after the top pair midway around the bend still in the three path, challenged again between rivals crossing the dirt, had to steady behind FREEDOM'S NOT FREE at the top of the lane and flattened to fourth. TRIPLE DIAMONDS vied for the lead from inside, dueled with STYLE CAT midway around the bend, fought inside a trio of rivals entering the stretch could not kick on with FREEDOM'S NOT FREE in upper stretch and weakened in the furlong grounds. STYLE CAT grabbed the early lead between rivals, dueled outside TRIPPLE DIAMONDS on the turn, fought between foes leaving the bend, yielded in upper stretch and also weakened. MAXIMUS chased in the four path approaching the turn, quickly moved into the three path, remained off the inside trailing the field to the stretch and came up empty when called upon.
