MARAE'S GIRL stepped to the front and set the pace under pressure from STAY AND SCAM, maintained a short lead to the top of the lane, disposed of that rival in upper stretch but was immediately confronted by QUEEN MAXIMA, was no match for that rival in the final furlong but was clearly second best. LAULNE (FR) stalked the top pair outside a rival, took the turn two wide and got up for third. STAY AND SCAM pressed the pace from outside, stayed alongside MA RAE'S GIRL around the turn, lost touch with that rival in upper stretch and flattened to fourth. MISS ROBERTS (GB) broke a step slow, was a bit rank in the early going, chased three wide around the bend and weakened. ARCTIC BREEZE trailed along the inside, tipped out into the stretch and failed to make an impact.
