STUBBY tracked the early pace, was hard held along the backstretch, raced four wide through the second turn and was along for third. PINK PACIFIC set a pressured early pace, was eased back for the run along the backstretch, couldn't sustain the run and weake ned late. ROGUE JUSTICE was allowed to settle early, raced along the inside into the home turn, passed rivals late and offer ed no late rally. MAYSAM was very fractious in the gate, was off a step slow, was rushed to be in a settling position along the back stretch, was hard ridden going five wide into the second turn and flattened out in early stretch. STREET COLORS pressed the early pace, raced three wide into the second turn and faded.
