IDRATHERBEBLESSED showed the way while remaining a bit off of the inside, dug in to resist bids on either side in upper stretch, sparred gamely with his inner challenger through the final furlong and clung to an advantage. GIGANTE stalked close up along the inside, slipped through to bid inside of the leader in upper stretch, dueled through the final furlong but was fended off. CAMEO PERFORMANCE was brushed by an inner rival at the start, pursued from midpack near the inside, then in the three path and between rivals turning for home, moved out from the five path to the seven path in upper stretch and rallied but needed more late. SPIRIT OF ST LOUIS pursued from midpack in the three to four path, floated six wide into the lane, offered grinding progress into the final furlong to issue a late bid for show but got outkicked. HIGGINS BOAT pressed the leader from the three path, bid in upper stretch, but was kept at bay before yielding late. REDISTRICITING (GB) tracked from the three path, drifted out to the five path into the lane but lacked a kick between horses. REBEL RED (GB) laid off of the pace in the three path, then in the four path and between horses turning for home, swung out to the seven path entering the lane and failed to menace. BRILLIANT BERTI laid well back in the two path moved out into the backstretch before pursuing from the three path around the far turn, entered the lane in the four path and failed to factor between horses. WHAT SAY THEE brushed an outer rival at the start, saved ground off of the pace, but to no avail. DANCIN IN DA'NILE trailed along the inside and made little impact. SMOKEY MANDATE lacked speed in the four path, got hung in the five to seven path around the far turn and tired. JOHNNY'S FIREBALL tracked from just off of the inside, chased in the lane and faded between horses in upper stretch.
