RUE LALA bumped an outer rival at the start, pursued from midpack in the three path and between horses, advanced in the four path into the lane, bid at the three sixteenths pole, drove clear and held sway. EYE OF THE PHARAOH laid off of the pace in the three path, moved out to the six path in upper stretch, rallied to split foes at the furlong grounds and was second best. TOMMIE G leaned inwardly and bumped a foe at the start, laid off of the pace along the inside, shifted out to the four to five path before steadying from an inner rival at the three sixteenths pole, then rallied between horses to gain show late. SIX STRING raced off of the pace along the inside, bore to three path into the turn, shifted out in upper stretch and ran on between horses. WON DAY tracked in the three path, was wrangled back in the four path while pursuing a bearing rival around the turn, veered out to the seven path in upper stretch and stayed on evenly. BOX OF PICTURES lunged leaving the gate before steadying out of crowded quarters once pinched between horses at the start, raced well back in the two path and advanced between horses. LUYV pursued from the five path before drifting to the eight path into the lane and failed to menace. TENSAS LUCY tracked along the inside, chased and gave way. BAYOU BERTIE vied along the inside, cleared once her outer counterpart bore into the turn but was collared by an outer bidder at the three sixteenths pole and weakened between horses. CLASSY JUDY G vied with an inner rival early on, but bore to the four path into the turn, got floated to the five path into the lane and weakened between horses. FROM SCRATCH stalked from the two path, chased in the three path in upper stretch and faltered. SASSI STRUTTER was bumped between horses and pinched back at the start, trailed along the inside, steadied nearing the turn and got outrun.
