Purse \$165,000 ( includes \$15,000 FTBOA – FL TB Owner Brdr Assoc Fund ) FOUR YEAR OLDS AND UPWARD. Free nomination by Sunday, March 16. \$1,500 to enter. A supplemental nomination fee of \$150 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. \*(FTBOA offers up to \$15,000 to the owners of Registered Florida-breds, divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: 124 lbs. Non-winners of a graded stakes at a mile or over since September 1 allowed 2 lbs.; Graded stakes placed since then or non-winners of a non-restricted stakes race at a mile or over since August 1, 4 lbs.; three races other than maiden, claiming, starter or state-bred allowance, 6 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners 2024-25, graded stakes-placed 2024-25, non-restricted stakes winners 2024-25, then by highest career earnings. Trophy to the winning owner.**

WHITE ABARRIO raced in the two path around the first turn, chased the leader between horses up the backstretch, dueled from the two path around the far turn and drew off in the lane. POWER SQUEEZE raced in the three path around the first turn, tracked the pace setter on the outside up the backstretch, dueled from the three path around the second bend and could not go with the winner in the lane but kept on to the wire. TUSCAN SKY saved ground early, settled in the middle of the pack for the run up the backstretch, began to move up while saving ground around the far bend and kept on in the stretch, no match for the winner. LIGHTNING TONES raced off the pace in the two path through the opening half mile, drifted out to the four path coming around the far turn and showed no kick. THE THOR (CHI) saved ground around the first turn, raced off the pace on the inside up the backstretch, navigated the second bend from the three path and made no bid. ONE SHARP COOKIE led the way from the two path around the first turn and up the backstretch, dropped back headed into the far turn and continued to tire from there.
