KIMCHI CAT with the early pace in the two path, vied between horses through the turn, continued between rivals through upper stretch then drove strongly clear in a solid effort. KENTUCKY SMOKESHOW forwardly placed three wide, pulled into the turn, crept a bit closer late in the bend, remained in contention outside the winner through upper stretch then proved no match the final furlong, held the place. ESKENFORARISE back off the pace and the inside, ranged up into a forward position five wide late in the turn, lost some ground to the top two as a result, set down for the drive, not enough late for the place. BATTLESHIPPER set or forced the pace along the inside, continued to head up the first flight through the turn, weakened down the stretch. GLEE within striking distance outside, four wide through the turn, lacked a closing punch from between horses down the lane. GUNITITE MAX last away, raced back and outside, three to four wide through the turn, failed to muster a rally. ACCELERATING within striking distance early along the inside, in tight, lost action after a furlong, fell back, no subsequent bid in coming up empty for the drive.
