No nomination fee. \$750 to pass the entry box and \$750 additional to start. Supplementary nominations may be made by the closing time of entries at a fee of \$2,000 which qualifies to start. \$145,000 Guaranteed. After paying 2.5% of original purse to the owners of horses finishing 6th through last, 60% of the remaining purse will be paid to owner(s) of the winner, 20% to second, 10% to third, 6% to fourth and 4% to fifth. Weights: 124 lbs. Non-winners of \$50,000 twice allowed 3 lbs.; \$50,000 once 5 lbs.; \$35,000 once 7 lbs. (Maiden and Claiming races not considered in allowances). In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings. Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. Closed Saturday, March 15, 2025 with 24 nominations.

MISS MARTINI unhurried in mid pack for a half toward the inside, swung out sharply to be five wide turning for home, closed with good resolve to be in time down the middle of the strip. PRAYING broke sharp, set the pace in the two path, continued to hold the advantage through the rail, dueled upper, gave ground grudgingly to the winner late while digging in for the place. GOOD CALL forwardly placed inside and in hand, challenged along the rail into the lane, dueled past the furlong marker, could not contain the winner either, outkicked for the place. TROUBLE IN LOVE behind the leaders while racing off the inside, continued in the two path while behind traffic for much of the turn, went evenly through the stretch when clear. VIGGIEDAL prompted the pace for a half in the three path, weakened from between horses entering the stretch. WISCONSIN GAL mid pack and out in the strip, four wide through the turn, closer inside the winner turning for home, flattened out in the drive. WHATA MOON steadied at the start to be off slowly, moved out, four wide late in the turn, failed to muster a rally. ESKENFORARAISE lacked speed outside, four out to five wide late in the turn, failed to muster a rally. SPANKERBOOM in mid pack early three wide, fell back in the turn, was not a factor through the stretch. COMPLEX SECRET fell back to trail after the start and was always outrun.
