MUCHO MACHO GIRL saved ground stalking the early pace, angled out to bet hree-wide coming to the quarter pole, took the lead from FLAME MCGOON nearing the eighth pole and quickly drew clear. FLAME MCGOON prompted AVENTAPP whileracing two-wide, took the lead from that one leaving the three-eighths pole then set the pace to near the eighth pole but was unable to resist the winner and held on for second. JAMIES INHERITANCE was reserved off the early pace, rallied two-wide into the stretch and closed strongly. VALENTINA DAY saved ground while being unhurried, angled out for room nearing the eighth pole and was gaining late. KYNLIE'S EMPIRE was prominently placed early while racing three-wide, came five-wide into the stretch but lacked a rally. CRYSTAL COAST saved ground while being allowed to settle but was unable to seriously threaten. EMPRESS ELLIE saved ground while dropping back early and failed to be a factor. AVENTAPP set the pace for five furlongs and gave way readily when headed.
