NO CHANGE unhurried down the back stretch, circled the field six deep around the far turn, tenacious drive rallied outside SOCIAL CHIC just missed. JUNGLE BEAST tracked the pace three wide down the backside, asked between into the lane, chased on willingly to secure the show. MUAD'DIB raced off the pace four deep into the far turn, drew even with the leaders leaving the furlong marker, need more through the final sixteenth. PAYMENGOLD set a pressured pace inside to the farturn, under pressure inside faded through the lane. DORADO roused on mid pack down the back stretch, chased just off the rail into the lane, never fired late. BIG JOEB very slow into stride, five wide into the lane, came up empty. ROCKET APPEAL chased the pace inside into the second bend, gave way. LORD OF CORK prompted the pace two wide into the far turn, weakened. MARSHALL PEANUT urged on inside down the backside, faltered.
