POSITANO SUNSET tracked along the inside, awaited racing room behind the main group nearing the lane, split foes three wide to issue a bid while being brushed by an outer rival at the furlong grounds, then edged past under a drive. EMERY vied with an outer rival into and around the turn, brushed lightly with that one entering the lane, battled gamely inside of trio of foes at the furlong grounds, but was bested and held place. MY MANE SQUEEZE leaned outwardly at the start, chased in the four to five path, sustained grinding progress in upper stretch, shifted in and brushed a rival while bidding four wide at the furlong grounds, but leveled off. MYSTIC LAKE vied two wide, brushed with her inner counterpart entering the lane, remained under confident handling in upper stretch, but came under a drive between horses as an outer pair issued challenges at the furlong grounds and gave way. DAZZLING MOVE stalked outside of the top pair while remaining in the four path around the turn, chased between horses in upper stretch and faded. JUSTIQUE broke a step slow, trailed in the two path, moved out to the six path in upper stretch and made little impact.
