CABO SPIRIT stepped to the front and moved inside, controlled the pace up the backstretch, met the bid from KING OF GOSFORD (GB) on the far turn, inched away from that rival late on the bend and held well under left handed encouragement. KING OF GOSFORD (GB) was closest in pursuit of the leader early from the two path, challenged from outside around the far turn, lost touch with CABO SPIRIT turning for home, continued to chase determinedly after the winner down the lane but had to settle for second best. ENDLESSLY got crowded between rivals early, traveled two wide at the back to the quarter pole, swung five wide approaching the stretch and gained third. ZIO JO got brushed by outer rival and checked in tight early along the fence, stalked from inside through both turns, asked right handed in upper stretch and lacked the needed response. IL BELLATOR pulled two wide into the first turn and quickly shifted into the three path, moved back in a path around the bend, stalked between rivals in hand up the backstretch, chased two then three wide around the far turn and weakened. PHOSPHORESCENCE (FR) brushed ZIO JO early then moved inside, saved ground through the far turn as well and was never a factor. ST ANTHONY tracked four then three wide around the clubhouse turn, rounded the far turn three wide then came four wide into the lane and faded.
