CORRINA CORRINA unhurried in the early going, saved ground to the second turn and advanced nearing the quarter marker, angled three wide into upper stretch then vied for the lead into the lane, took command at the furlong marker and pulled away late under hand urging. I THINK I'M HERE tracked the early pace from the second flight, chased three to four wide into the second turn, spun four to five wide into upper stretch and ran in pursuit to the furlong marker, was no match for the winner into the final sixteenth and stayed on late to be second best. PROBATE sent to assume the early lead, set a contested pace between rivals up the backstretch, dueled MARKING CANYON into the far turn then showed the way into upper stretch, met the bid of CORRINA CORRINA into the lane, could not keep pace with the winner past the furlong marker, yielded to the top pair late and was clear in the end for third. DAVE'S ENCHANTMENT stalked the early pace while five wide into the first turn, contested the pace while widest of the first flight into the backstretch, lost position at the half-mile then chased into the far turn, ran in pursuit four wide into upper stretch, could not find more into the late stages and weakened. MARKING CANYON prominent away from the start, pressed the pace from the inside into the backstretch, dueled PROBATE into the far turn, lost position into upper stretch, chased to the furlong grounds then faded in the final sixteenth. LUCK IN MY EYES allowed to settle early, trailed along the backstretch, advanced along the inside into the stretch, could not sustain that run and flattened out late. I'M A GAMBLER close up early, prompted the pace three wide and between runners into the backstretch, lost position past the half-mile pole, chased three to four wide nearing the quarter marker, could not muster a late response and tired in the stretch drive. BODIE GOT GOLD allowed to settle early, chased three wide along the second turn, lacked a response into the stretch and did not factor in the late stages. GEORGE WHO forwardly placed away from the start, stalked the early pace four wide along the first turn, disputed solid fractions while four deep and between runners along the backstretch, could not keep pace into the second turn then came up empty in the stretch drive.
