RANDOMIZED came in a bit entering the first turn and set the pace early on, raced in the two path into the lane, fought on down the lane under a long drive but gave in and lost place in the final stages. DORTH VADER was bumped and steadied into the first turn along the inside, tracked the pace early on, stayed near the rail into the lane and put in tight a bit near the three sixteenths pole but stayed on in the late stages. FREE LIKE A GIRL raced in the four path along the first turn, chased the pace early on, was in the five path into the lane and flattened out late in the stretch run. LITERATE broke a tad slow at the start and trailed the field early on, raced in the three path along the first turn, fanned into the six path entering the lane and improved a position late in the stretch drive. THORPEDO ANNA was bumped while between horses going into the first turn, raced in the three path along the first turn and stalked the early leader, raced in the three path into the lane and was tired down the lane.
