POWDERED SUGAR was allowed to settle into stride from the break then pulled the rider to the lead, joined up with SHE'S MAGNIFICENT at the half-mile pole and dueled inside through the turn, was always traveling well then responded when set down in upper stretch, went clear entering the furlong grounds and closed the deal under strong handling and intermittent urging. CC COLA settled well off the pace two deep down the backstretch, kept to the inside through the turn then was in a stiff drive for the whole of the stretch run and gained second in the final yards. SHE'S MAGNIFICENT was quick to the front with the rider trying to temper the pace was joined by POWDERED SUGAR at the half, went together with that rival through the turn then kept on trying when that foe got away in the stretch, but was outfinished for the place. INCOGNITO BURRITO stalked the dueling leaders, went three wide on the turn, bid for the lead three deep at the top of the stretch but was outfinished in the late stages. LOLA AND ROSE was at the back of the tightly bunched field down the backstretch racing three wide, made a four wide bid around the turn, was with a chance turning into the stretch but flattened out and could not threaten late. BET TOWINIT stumbled at the start, rushed up three wide to press the leaders before the turn, started to lose ground leaving the three furlong pole and was uninvolved in the stretch.
