TANK bumped with the horse to his outside at the start, raced in the two path around the first turn, chased the leader up the backstretch, challenged from the two path coming around the far turn, dueled in upper stretch and got up for the win late. WIN WITH FAITH raced off the pace on the inside through the opening half mile, navigated the far turn from the three path, launched a bid entering the stretch and gained ground late. FORGED STEEL saved ground around the first turn, led the way up the backstretch, dueled from the rail around the far bend and into the lane and gave way late. NEMO raced in the two path early, settled off the pace on the outside for the run up the backstretch, navigated the far turn from the three path and improved position in the stretch. INSUBORDINATION (IRE) raced in the four path around the first turn, settled in the middle of the pack on the outside for the run up the backstretch, began a bid from the two path coming around the second bend and flattened out in the stretch. I'M DUE raced in the middle of the pack in the two path through the opening half mile, came around the far turn still in the two path and was empty in the lane. BAKERSSTREET bumped with the horse to his inside at the break, saved ground around the first turn, tracked the leader on the inside up the backstretch, continued to save ground around the far turn and faded from there. DREAM SCHEME raced in the two path early, settled in the middle of the pack on the inside for the run up the backstretch, began to drop back coming around the far turn and continued to tire in the stretch.
