ONE TEN STADIUM broke forwardly, tracked the leaders in the second flight along the inside, waited briefly along the inside late in the final turn, got through, closed with good resolve to be up in time. CYBERTOWN back off the pace in the two path early, closer three wide late in the second bend, in some traffic upper stretch, moved out a bit to brush with STRIKE RIDGE, gained the second position late and had enough to hold that position late. LOCH MOOR settled off the pace and the inside, four wide through the second turn, also encountered some traffic upper stretch, moved out, bumped with READY SHOES, roused, finished well to be going best of all late. ZIPPY MARK settled in the second flight while three wide, continued to stalk three wide, took over turning for home, showed the way past the furlong marker but could not last. GREAT BARRIER dueled up front in the two path, weake ned in the drive. STRIKE RIDGE five wide through the first turn when off the pace, continued out in the strip, five to four wide second turn, brushed upper, weakened. MAN IN THE CAN dueled up front while closest to the inside, faltered when the real running be gan at the head of the lane. WILLOW CREEK ROAD keen in the first turn when off the pace, settled in the run up the backstretch, failed to respond in the drive. READY SHOES four wide in the first turn, continued out in the strip, four to five wide second turn, bumped upper stretch by LOCHNOOR, angled in and lacked a kick. BURLSWORTH lacked speed while angling in a bit first turn, three wide second bend, remained back. HOLDING PATTERN off a step slow, was never a factor. HOPPIN JOHN void of speed, four wide second turn, was never a threat. CHEZ WHIZ was also always outrun, trailed home.
