SK YBOOM slightly bothered at the start when rival drifted out a path, quickly advanced to track the early pacesetter, came under a rideleaving the backstretch, continued to hustle along trying to make headway on pulling away leader around the turn, turned two wide for home, sustained a steady bid and settled for second best. K AN OJO was restless and unseated the rider loading then came away a step awkward at the start, raced off the early pace, hustled along two wide into the turn, remained two wide in pursuit down the lane and secure da share. GLAD VON D raced three deep in the flight off the leader, hustled along three wide into the upper stretch and lacked the needed response for late impact. UNSPOKEN TRUTH raced off the early pace, swung four to five wide into the upper stretch and lacked a rally. SUNSET FOR SANDRA broke out at the start and advanced to be forwardly placed tracking the early leader, continued in contention leaving the backstretch, came up empty mid-way around the turn and steadily retreated.
