SANTA BARBARIAN raced three deep at the back into the first turn, moved into range outside a rial on the backstretch, drew closer under asking in the three path on the far turn, drew alongside CALICAT inside the eighth pole, fought gamely while getting floated out by CALI CAT and dug in for the upset. CALI CAT stalked three then two wide early, bid three deep past the threeeighths pole, dueled outside DROP UM midway around the bend, disposed of that rival approaching the stretch, met the challenge from SANTA BARBARIAN past the eighth pole, resisted while drifting out into the final fifty yards and yielded grudgingly late. GOT SOUL angled to the inside racing near the back early, pulled between rivals on the clubhouse turn, asked two then three wide on the second bend, finished well to gain third but could not reach the top pair. DROP UM was closest in pursuit from the two path early, applied pressure to the leader from outside midway around the clubhouse turn, moved upon terms whilerank past the fiveeighths pole, put a head in front dueling up the backstretch, fought inside CALI CAT at the five-sixteenths pole, failed to keep up entering the stretch, kept on trying down the lane while drifting out and saved a minor award. PRINCE OF DEL MAR settled two wide then found the rail, shifted back to the two path to go around BRO BRO on the far turn, cut the corner entering the stretch, moved out with a furlong remaining and lacked a bid. STYLE CAT stalked the speed from the fence, shifted to the two path to get out from behind BRO BRO past the three-eighths pole, came under a ride around that bend but weakened in the drive. WESTERN FREEDOM unhurried in the opening stages on the inside, moved out to pass a tired rival on the far turn, eased in the lane and walked off. BRO BRO established an early lead along the inside, took pressure around the clubhouse turn, lost command dueling in the middle stages, dropped back on the far turn, pulled up past the eighth pole, bled following the race and was transported off the track via equine ambulance.
