KENNEBEC swung wide entering the stretch, found his best stride late and was gaining fast. WHAT A DUDE stalked the pace, challenged for the lead on the final turn and went willingly to the wire. SALINE RIVER led early, stalked the pace and lacked the needed late response. CORNISHMAN bumped at the start, was never far back and and lacked the needed late rally. NONE ABOVE THE LAW was unhurried early, offered a mild bid only and improved position. I AM FREAKY FAST trailed the field and put in a steady effort to improve position. TALLIS stalked the pace, had nothing left for the drive and gave way. CAPIAT bumped at the start and was outrun. UNCHARTED was through early. This race had a timing discrepancy or malfunction and was re-timed using video technology to arrive at the most accurate time.
