Equal Weight 122 lbs. Starters and riders must be named through the entry box by the usual time of closing. This race will be limited to fourteen (14) horses with preference to start given to those who have accumulated the highest career earnings in 2024–2025. Failure to draw in cancels all fees. LO BUG stalked the pace early on, chased the leader nearing the lane, was in the five path into the lane, made a bid in the upper stretch, lugged in under right handed urging and bothered SILVER KISS in the process while under a long drive and edged clear in the final stages. WONDER WORLD was unhurried early on, raced in the six path into the lane, rallied down the lane and prevailed for place at the wire. CARMEL ROSE chased the pace early, raced in the four path into the lane, rallied down the lane and missed place in the final stages. SILVER KISS raced in the six path along the first turn and set the pace, raced in the four path into the lane, was bothered and steadied nearing the eighth pole and weakened late in the drive. GOOSEBUMPS raced in the five path along the first turn while back early on, was in the three path into the lane and flattened out late in the stretch run. PARLAY raced in the five path along the first turn while vying for the lead, stalked the pace down the backstretch from the inside, was in the two path into the lane and faded late in the stretch drive. LIZZY'S DREAM was never involved. FOLLOWING A STEWARDS INQUIRY LO BUG WAS DISQUALIFIED AND PLACED FOURTH FOR INTERFERENCE IN THE STRETCH RUN AGAINST SILVER KISS.
