HENRY MAC raced back early on, was in the four path into the lane, rallied down the lane but missed place in the final stages while prevailed for show at the wire. STAGE NAME hopped at the start and raced back early on, was in the three path into the lane, altered to the rail in the stretch with a late bid from the inside and missed show in the final stages. RUFFIN set the pace early on, raced in the four path into the lane and weakened late in the stretch run. RIVER BOAT was unhurried early on, raced in the five path into the lane with a mild gain late in the stretch drive. HIP HOORAY chased the pace early on, was in the two path into the lane and faded late in the stretch. ORFANO was never a factor. GOLDEN FLAG was through after a half. SHADOWY was done early from the inside.
