Purse \$30,000 (plus \$6,000 State Bred) FOR COLTS AND GELDINGS, THREE-YEAR-OLDS AND UPWARD, THAT HAVE BEEN STABLED AT FORT ERIE RACE TRACK FOR 30 DAYS PRIOR TO JUNE 15, 2025 BY A TRAINER WITH STALLS ALLOCATED AT FORT ERIE RACE TRACK FOR THE 2025 RACING SEASON; OR A HORSE THAT HAS BEEN CLAIMED OR PURCHASED SINCE MAY 16, 2025 BY A TRAINER WITH STALLS ALLOCATED AT FORT ERIE RACE TRACK FOR THE 2025 SEASON. By subscription of \$50 each which shall accompany the Nomination and an additional \$250 when making entry with a purse of \$30,000 Guaranteed, Plus up to \$6,000 for eligible Ontario Breds. Horses not originally nominated may supplement at time of final entry by a non-refundable fee of \$600 which includes the entry fee. Weights: Three-Year-Olds, 120 lbs.; Older, 124 lbs. Non-winners of three races in 2025 allowed, 2 lbs. (Races with claiming prices of \$6,250 or less not considered in allowances) The field will be limited to 12 starters. If more than 12 entries pass the entry box, preference will be given to the highest earnings in 2024-2025. Final entries to be made through the entry box at the closing time then in effect for overnight events. Closed Sunday, June 1st. with 15 Nominations, plus 2 Supplements.

GAROFOLI stalked the early leader, was a factor on the turn and from the four path at the top of the stretch drew clear. VICTORY MARCH was unhurried early, moved up on the turn and from the six path at the top of the stretch was up for place. SHAKOO MAKOO set the pace and had the lead on the turn but from the three path at the top of the stretch gave way. BELLA FUTURE was in touch and raced evenly from the inside on the turn but from the three path at the top of the stretch had no kick. NAME OF THE GAME was off slow and roused on the turn but from the five path at the top of the stretch had no response. DIOMEDES was off the pace, trailed the field on the turn and was never in contention. SEA TO AIR raced in mid pack early but was in tight on the turn and from the four path at the top of the stretch had no impact. A CLAIM OF FOUL BY THE RIDER ON SEA TO AIR AGAINST NAME OF THE GAME FOR ALLEGED INTERFERENCE ON THE TURN WAS NOT ALLOWED.
