GOL DEN AFTERNOON prompted the pace down the backside, narrowed the margin on the turn edging closer to the pacesetter to engage that one turning for home, dueled in upper stretch on the lead and pulled away in the final sixteenth convincingly. BIG VINCE reserved off the pace between rivals in tight quarters at the half mile pole, followed the winner's rally on the turn in the clear, was bumped through the lane by outside rival and finished well to be up for the place. GOOD DIRECTIONS slow away from the gate to be well off the pack for the first half, cut into the margin on the turn and rallied determinedly through traffic making his own hole inside the eighth pole and hithis best stride late when in the clear to be surging in the final yards. FASTER GATOR tracked the leaders from four wide into the turn, rallied on the bend to loom turning for home, could not sustain the bid while bumping with BIG VINCE midway in the lane and finished evenly late. BALLAD OF WARRIOR unhurried in the early going to beat the back of the main body of the field, angled out six wide at the top of the lane and showed some interest in the lane with a mild bid. MAKEIT TO CHEYENNE sped to the lead shortly away from the gate, opened a clear lead at the half mile pole, responded when challenged by the winner on the turn to duel to mid-stretch and weakened in the final eighth. MENSA well place stalking the leader from the fence into the turn and steadily gave way on the turn.
