**6 FURLONGS. ( 1071 ) ED SKINNER S. Purse \$50,000 ( plus \$12,250 IBF – Iowa Bred Fund ) FOR THREE-YEAR-OLDS & UPWARD. Weights: Three-Year-Olds – 120 lbs.; Older – 125 lbs. Non-winners of \$60,000 in 2024–2025 allowed 2 lbs.; non-winners of \$45,000 in 2024–2025 allowed 4 lbs.; \$30,000 in 2024–2025 allowed 6 lbs. ( Maiden and claiming races not considered ) No nomination fee. \$250 to pass the entry box and \$250 additional to start. \$50,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$750 TO ENTER AND START. Starters to be named through the entry box at the usual time of closing. Should this race not be divided and the entry number exceeds twelve (12), high weights will be preferred, then highest 2024–2025 earnings at the closing time of entries. Different owners will have equal draw according to weights. The second parts of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees. Closed on Saturday, May 24, 2025 with 15 nominations.**

GLENGARRY sped to the lead at the start, cleared and angled in a couple paths, led the way under some pressure from KATAR going by the half mile marker, edged ahead still unleashed entering the turn, took on the rail bid from DIAMOND RIM approaching the quarter pole, remained confidently handled then came under a ride turning for home, dueled into the upper stretch, came under left handed pressure, shook free from DIAMOND RIM approaching the furlong marker and finished going away. DIAMOND RIM was forwardly placed along the inside, advanced along the rail to engage GLENGARRY for the lead approaching the quarter pole, vied into the upper stretch, could not match strides with rival past the furlong marker, ran on and finished clearly second best. KATAR applied pace pressure to GLENGARRY in the opening quarter, could not remain in touch with rival leaving the backstretch, weakened past the mid-way point around the turn and stayed on for a share. DESPERATE MAN raced outside in contention mid-way up the backstretch, chased three wide in range around the turn then came up empty at the head of the lane.
