W ON HAPPY MAMA broke alertly from the outside and angled in a couple paths, vied for the lead three deep in the opening quarter, shook free leaving the backstretch, held firm around the turn, was ridden along two wide into the upperstretch, came under right handed pressure, turned back the rail bid from HANKS GIRL and kept clear. HANKS GIRL vied for the lead in the opening quarter, edged back into tracking position leaving the backstretch, sat just off WON HAPPY MAMA around the turn, launched a rebid along the rail top of the lane, advanced into close contention but could not reach eventual winner and had to settle for second best. INTERSTELLA rated off the early pace, came under a ride three to four wide late on the turn, sustained a steady bid down the lane and gained a share. DEMIDANU came away last, steadily edged up closer along the rail up the backstretch, hustled along two wide going by the quarter pole, ran on one-paced down the lane and got edged for show. MISS PEACH raced in the back, saved ground around the turn and lacked a needed rally. OURPEPPERMINTCANDY vied for the early lead, chased in contention around the turn then faded in the lane.
