Dk. b or br. m, (Mar), by Girvin - Hardcore Candy, by Yonaguska. Trainer Weaver George. Bred by John Ropes (Fla). DORTH VADER just off the inside through the first turn, raced three then two wide in pursuit in closest aim of the leader patiently handled until placed to coaxing near the quarter pole, got roused spinning three wide into upper stretch, rallied to take command near the eighth pole, edged clear to the finish kept to task. DAZZLING MOVE established the front just after the break and showed the way in hand just off the inside, shook away midway on the turn before coming under growing threat to the outside. got set down angled four wide into upper stretch, dug in under threat and was collared a furlongout, kept on to the finish to preserve the place honors. RAGING SEA got bumped at the start by TARIFA due to pressure from RANDOMIZED breaking inwards and was bumped and squeezed out between foes making contact with LESLIE'S ROSE and conceding three lengths immediately to the front before settling into stride, raced just off the inside through the first turn growing detached at the tail of the field, tipped out six paths off the inside down the backstretch, tucked three wide into the far turn and came under coaxing nearing three furlances to go, angled five wideinto upper stretch and kicked on belatedly to procure the show honors. TARIFA bobbled at the start and was bumped by RANDOMIZED and in turn bumped and squeezed back RAGING SEA against LESLIE'S ROSE and conceded two lengths to the front, raced three wide through the first turn and then chased five paths offthe inside down the backstretch, tucked three wide through the far turn coming under coaxing at the three-eighths, spun three wide for home and tired. RANDOMIZED broke in at the start bumping TARIFA into RAGING SEA and in turn LESLIE'S ROSE, squeezing out RAGING SEA, who got the worst of it, went three wide through the first turn, chased four paths off the inside down the backstretch and then just off the inside through the far turn ridden along three furlongs out, spun just off the inside into upper stretch and faltered in the drive. LESLIE'S ROSE got bumped at the start by RAGING SEA and squeezed that foe out in tandem with TARIFA, chased just off the inside through the opening turn before tipping three wide down the backstretch, advanced into the far turn tucking to the inside before beginning to retreat with seven-sixteenths to go, backtracked through the remainder of the turn and cornered three wide for home, then got eased home through to the finish to a walk and then walked off under her own power.
