**INNER TURF FOR FILLIES AND MARES THREE YEARS OLD AND UPWARD (REGISTERED VIRGINIA BRED/VIRGINIA SIRE).** No nomination fee. \$300 to enter and \$300 to start. Supplementary nomination of \$1250 (which includes entry and starting fees) may be made at time of entry. \$125,000, with 60% to the owner of the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weights: Three year olds 120 lbs.; Older 124 lbs. Non-winners of a sweepstake since January 1 allowed 2 lbs. Starters and riders to be named through the entry box by the usual time of closing. This race will be limited to fourteen (14) starters. In the event more than fourteen entrants pass through the entry box, preference will be given to stakes winners, then highest turf earnings in 2024–2025. Any horse excluded due to the aforementioned preference shall be refunded the entry fee and supplementary nomination fee, if applicable. Trophy to the winning owner. Nominations closed Wednesday, July 2, 2025 with 18 nominations. (Rail at 40 feet).

NOQUESTIONABOUTIT was away alertly and pressed the pace under a hard hold two wide, made a two to three wide bid to be clear by the five sixteenths, challenged nearing the furlong marker to her inside by MYSTIC SEAPORT but turned back that bid and kicked clear to prove best under a drive. MYSTIC SEAPORT tracked the pace from between rivals and made a two wide bid leaving the turn to loom boldly by the furlong marker but flattened out while saving the place award. THREE TIMES was hard held on the inside, checked by the three eights marker and fell back, then finished well on the inside just missing the place award while gaining the show award. CHICKAHOMINY was allowed to settle early, three wide on the turn and came five wide off the bend and had a mild late rally but was out-kicked for the place award. CAROLINA SUN tracked the pace three wide and weakened in the drive. SPLASH OF JACK was bumped after the start, then was out-sprinted early and never factored. LENAMAGNETTA set a pressured pace on the inside and stopped in the lane while losing the crop at the sixteenth marker. STEWARDS INQUIRY into the running of this race but after reviewing the replays there was no change.
