CHAI chased the pace racing along the inside and weakened during the drive and ended up finishing on even terms with SHOCKING GREY in a dead-heat for fifth. SHOCKING GREY settled in the back of the field, rallied four-wide into the stretch and failed to seriously threaten while ending up in a dead-hear for fifth. VULIN was unhurried early, rallied three-wide into the stretch but was not a factor.
